I. CALL TO ORDER

The meeting was called to order at 10:09 A.M. and roll was called. No conflicts of interest were noted.

II. APPROVAL OF AGENDA

It was moved by Commissioner Kolbeck and seconded by Commissioner Pummel that the Agenda be adopted as amended, but reserving the right to make further changes during the meeting.

III. EXECUTIVE DIRECTOR'S REPORT

Executive Director Lauseng reported that the Annual Board Meeting would be held August 11 at 1:30 p.m. in Pierre. During the meeting, the 2015 Highlights Report will be given by Directors in place of Program Reports. The Highlights Report for FY 2015 is in the final stages of being completed and will be distributed at the meeting. A tour of the Governor's House Program at the prison in Springfield will take place on August 12. Executive Director Lauseng also reported the National Council of State Housing Agencies Annual Housing Conference will be in Nashville from September 27 to the 29. SDHDA's Annual Housing Conference will be in Pierre on October 27 and 28.

IV. OLD BUSINESS

A. Resolution No. 15-07-39: Resolution to Modify Commitment of Housing Opportunity Funds for Thunder Valley Regenerative Project

After review and discussion, it was moved by Commissioner Hansen and seconded by Commissioner Kolbeck that the above Resolution be adopted as follows:

WHEREAS, per Resolution 13-12-111, a Conditional Commitment of Housing Opportunity Funds (HOF) in the amount of \$387,941 was previously awarded to the Thunder Valley Regenerative Project (Applicant); and

WHEREAS, Applicant has requested changes to the terms of the HOF Financing due to changes in the project;

NOW, THEREFORE, BE IT RESOLVED that the Executive Director be authorized to modify terms as specified on the Amended Conditional Commitment Summary.

B. Resolution No. 15-07-40: Resolution to Commit Additional HOME Program Funds for Sioux Falls YMCA Housing Initiative

After review and discussion, it was moved by Commissioner Pummel and seconded by Commissioner Puetz that the above Resolution be adopted as follows:

WHEREAS, per Resolution 13-04-34, a Reservation in the amount of \$668,780 was previously awarded to the following HOME Applicant;

WHEREAS, per Resolution 13-09-73, a Commitment in the amount of \$668,780 was approved;

WHEREAS, due to unforeseen demolition costs and change orders the applicant is requesting additional HOME funds to assist in financing the additional costs; and

WHEREAS, SDHDA is approaching a commitment deadline of July 31, 2015, at which time all 2013 HOME funds and available program income must be committed to eligible activities; allocation of additional HOME funds to the Applicant will allow SDHDA to meet this requirement;

NOW, THEREFORE, BE IT RESOLVED that the Executive Director be authorized to commit additional HOME Funds as follows, for a total commitment of \$559,151:

C. Resolution No. 15-07-41: Resolution to Commit Additional HOME Program Funds for Rapid City Good Samaritan Housing

After review and discussion, it was moved by Commissioner Hansen and seconded by Commissioner Kolbeck that the above Resolution be adopted as follows:

WHEREAS, per Resolution 14-05-24, a Reservation in the amount of \$439,387 was previously awarded to the following HOME Applicant;

WHEREAS, per Resolution 14-10-71, a Commitment in the amount of \$439,387 was approved;

WHEREAS, per Resolution 13-12-109, a Conditional Commitment of Housing Opportunity Funds (HOF) in the amount of \$226,800 was previously awarded to the following applicant;

WHEREAS, SDHDA is approaching a commitment deadline of July 31, 2015, at which time all 2013 HOME funds and available program income must be committed to eligible activities;

WHEREAS, SDHDA would like to replace the HOF allocation with additional HOME funds allowing SDHDA to meet this requirement;

NOW, THEREFORE, BE IT RESOLVED that the Executive Director be authorized to commit additional HOME Funds as follows, for a total commitment of \$226,800:

WHEREAS, the following HOME Program application was received for the Security Deposit Assistance Program (SDAP) set-aside; and

WHEREAS, the required documentation has been reviewed and evaluated, and the Applicant has agreed to comply with all HOME requirements;

NOW, THEREFORE, BE IT RESOLVED that the Executive Director be authorized to issue a conditional commitment of HOME funds from the SDAP set-aside for the following:

B. Resolution No. 15-07-43: Resolution to Commit HOME Program Funds under the Security Deposit Assistance Program for Housing and Redevelopment Commission of the City of Aberdeen

After review and discussion, it was moved by Commissioner Hansen and seconded by Commissioner Kolbeck that the above Resolution be adopted as follows:

WHEREAS, the following HOME Program application was received for the Security Deposit Assistance Program (SDAP) set-aside; and

WHEREAS, the required documentation has been reviewed and evaluated, and the Applicant has agreed to comply with all HOME requirements;

NOW, THEREFORE, BE IT RESOLVED that the Executive Director be authorized to issue a commitment of HOME funds from the SDAP set-aside for the following:
