## ANNUAL HOF REPORT 2018





## **OVERVIEW**



The **South Dakota Housing Opportunity Fund (HOF)** is designed to promote economic development in South Dakota by expanding the supply of decent, safe, sanitary and affordable housing targeted to low and moderate income families and individuals in South Dakota. The HOF was created via Senate Bill 235 the "Building South Dakota Fund" during the 2013 legislative session.



The SDHDA **Board of Commissioners** are responsible for the administration of the Housing Opportunity Fund in accordance with SDCL 11–13. SDHDA developed an allocation plan that provides a system to award HOF funds and HOF program income. HOF serves individuals and families at or below 115 percent of the Area Median Income (AMI) for the corresponding county. SDHDA distributes HOF funds geographically throughout the state.



In FY 2018, the **State of South Dakota** appropriated \$734,440 to the Housing Opportunity Fund. With program income and returned funds, a total of \$1.16 million was awarded by SDHDA, resulting in three multifamily rental units and four single family homes being built, 58 single family homes being rehabbed, 58 homebuyers receiving assistance and 43 individuals receiving homelessness prevention assistance.



Who can apply? Any for-profit entity, non-profit entity, tribal government, housing authority, political subdivision of South Dakota or its agencies, or any agency of South Dakota is eligible to apply for Housing Opportunity Funds. Individuals are only allowed to apply for program funding through HOF recipients.




Beginning FY 2019, SDHDA will accept **HOF applications** for housing development on a first-come, first-serve basis with applications accepted January 1 through July 31. These applications will be scored in accordance with the HOF Allocation Plan to ensure feasible and desirable projects are awarded funds. HOF applications for housing development that are received on or after August 1, will become part of the annual competitive application round along with HOF applications for program funding. Applications participating in the competitive application round are due the last business day in August by 5:00 PM CST.
