Funds were not fully utilized prior to previous year's grant end of 6/30/2023. All allocated funds were not utilized as total funds are based on FMRs with the assumption that participant pays \$0 rent. Not all units rented at FMR and some participants had income and paid a portion of rent. This resulted in less funds needed for rental assistance. We also implement a moving-on strategy with our program and encourage participants to apply for the Section 8 waiting list. As we have program turnover for those transitioning to Section 8 Housing Choice Voucher, we notice that the population this program serves often has difficulty with quick documentation gathering and quick lease-up after referral. The gaps in time between a participant transitioning to HCV and a new Shelter Plus Care participant leasing up lead to a portion of time when less HAP money is spent during the transition.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

The Sioux Falls Housing and Redevelopment Commission (SFHRC) has been administering the Shelter Plus Care program since 1995. This is a renewal of the Shelter Plus Care program which is a collaborative effort between SFHRC and an agency partner, Southeastern Directions for Life ("Southeastern"), to provide permanent housing with supportive services to 29 persons/households who are homeless and have a diagnosis of severe, persistent mental illness. Beginning with the FY 2013 renewal, priority has been given to persons who are chronically homeless whenever a turnover occurs, and, therefore, 100% of the beds are dedicated to serving this population. Based on average annual turnover this would be about 20-30% of the total participants assisted annually are new participants that meet this determination. Persons are referred to the Program and Southeastern Mental Health Services through the State of South Dakota's Coordinated Entry System. Both the SFHRC and Southeastern are in full compliance with Coordinated Entry for all of our CoC grants.

SFHRC provides scattered site, tenant-based rental assistance to program participants in a qualified housing unit of their choice within the city limits of Sioux Falls. SFHRC determines a person's eligibility, provides housing search information, determines the amount of rental assistance, provides security deposit assistance, if needed, and conducts a housing quality standards evaluation and qualification determination of the housing unit.

Southeastern Behavioral Health encourages and engages program participants in cooperating and utilizing the supportive services provided by Southeastern and targeted towards the needs of the individual. These services include case management, housing search assistance, psychiatric/medication management, group therapy, psychosocial rehabilitation, vocational services and supervision. Southeastern also assists participants with identifying and accessing appropriate federal, state and local benefits.

This program has had success in utilizing available beds and keeping participants stably housed. Projected outcomes are: 1) 85% of the participants will continue to remain stably housed at the end of the program year and/or exit to permanent housing. 2) Half of the participants that leave the program transition to permanent non-subsidized rental housing; 3) Annual bed utilization will continue to be at least 90%; 4) At least 70% of participants will receive cash benefits. The SFHRC agreed to take 28 additional Emergency Housing Vouchers in July of 2021. The 63 EHV's draw heavily from CES and compete directly for limited housing units in the Sioux Falls area. S+C grants are regaining ground as the 63-unit EHV grant is filled and stabilizing.



- Security Deposits. Grant funds can be used to pay for security deposits of the safe unit the survivor is transferring to via an emergency transfer(s).

- Utilities. Grant funds can be used to pay for costs of establishing utility assistance in the safe unit the survivor is transferring to.

- Housing Fees. Grant funds can be used to pay fees associated with getting survivors into a safe unit via emergency transfer(s), including but not limited to application fees, broker fees, holding fees, trash fees, pet fees where the person believes they need their pet to be safe, etc.

- Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).

- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).
