The project targets individuals who were chronically homeless with disability of chronic substance abuse. Five individuals are able to receive rental assistance to enable them to reside in a building that provides permanent housing for this targeted population. This building, called Safe Home, is owned by the Minnehaha County Housing & Redevelopment Commission with operational and supportive services provided by Minnehaha County Human Services. The participants are able to maintain their housing through supportive services which include intensive case management, life skills training, payee services, daily meals and transportation services. Participants are, also, linked with appropriate community services including health care, addictions treatment and access to mainstream benefits and/or employment. By providing permanent housing with appropriate services in a harm reduction environment, the participants are empowered to make lifestyle changes that will improve their quality of life and break the cycle of homelessness.

This program has had success in utilizing available beds and keeping this extremely difficult population stably housed. 1) In the most recent APR reporting period 100% of the participants remained stably housed in permanent housing for over 1 year. It is projected that this success will continue with at least 80% of the participants remaining stably housed at the end of the program year and/or exit to permanent housing. 2) Annual bed utilization will continue to be at least 90% 3) At least 20% of participants will receive cash or non-cash benefits since many have a difficult time getting the necessary documentation to qualify for benefits.

#### Grant Number: SD0021L8T002005 (Safe Home)

The two parties referenced above hereby enter into a Memorandum of Understanding (MOU) for documenting Minnehaha County Human Services("MCHS") in-kind contributions to the Safe Home - Continuum of Care Program, funded by the US Department of Housing and Urban Development, and administered by the Sioux Falls Housing and Redevelopment Commission in Sioux Falls, South Dakota.

MCHS agrees to provide Assessment of Service Needs, Case Management, Food, Life Skills Training, Outreach Services and Transportation as appropriate for chronically homeless households with substance abuse issues who are participants of the Safe Home - Continuum of Care Program. To deliver these services, MCHS will make available the necessary staff, space and supplies.

As per 24 CFR § 578.73, MCHS will provide appropriate services as outlined in the paragraph above. Rates for the services to be provided vary by service type and service provider. Staff positions providing the services include: Safe Home Program Worker, Safe Home Caseworker, Safe Home Program Assistant and Safe Home Manager. The range in cost per service is \$16.00 per hour to \$34.19 per hour. The cost for food is figured to be 15.2% of the food budget for the five (5) individuals utilizing the vouchers. The value of these services must meet the 25% match for this grant during the grant period, September 1, 2022 through August 31, 2023.

This agreement is effective October <u></u>, 2021.
