CoC Introduction

CoC Application Process

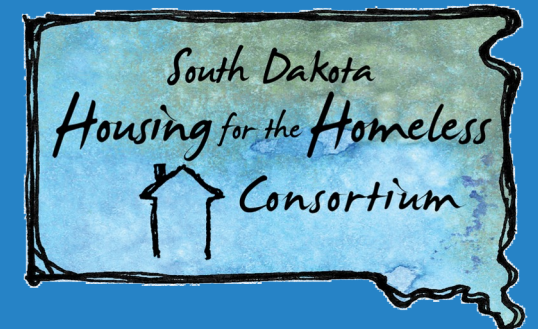
- The Continuum of Care establishes local competition to rate & rank projects applications
- Applicants submit project application to CoC & CoC either rejects or accepts & ranks based on rating & ranking tool
- The CoC submits CoC application & all project applications to HUD for review
- HUD reviews & ensure they meet threshold requirements & scores CoC applications
- Project applications funded based on combination of CoC score & how the CoC ranked the project



CoC Responsibilities

Collaborative Applicant

- Designated by CoC to collect/submit required CoC Application info for all projects CoC has selected for funding
- Apply for CoC Planning funds on behalf of CoC. Design, operate, & follow a process for development & approval of project applications in response to the NOFO
- Establish funding priorities for the local application process
- SDHDA SD-500 CoC Collaborative Applicant



CoC Project Types

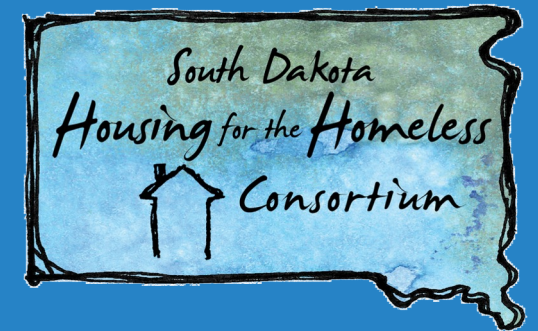
Transitional Housing (TH)

- Participants sign a lease, sublease or occupancy agreement for a period of at least one month.
- Leases/occupancy agreements renewable upon expiration, except on prior notice by either party, with a maximum term of 24 months.
- Must provide access to supportive services.
- Services may be provided to former TH residents for up to six months

Joint Transitional Housing-Permanent Housing

- Rapid Re-housing (RRH-TH)

- Offers both transitional housing & rapid rehousing. Not everyone needs to be enrolled in both.
- TH portion has the same requirements as only TH
- RRH portion has the same requirements as project only RRH



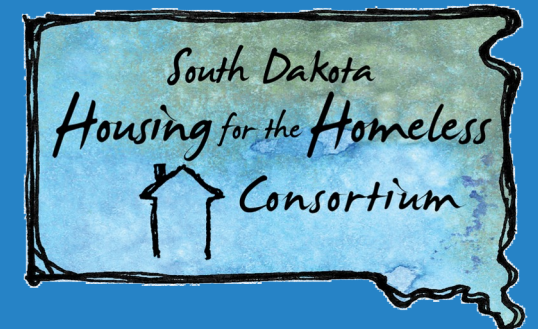
CoC Project Types

Support Services Only – Coordinated Entry (CE)

- CoC is required to have in place a CE
- CE includes processes for Access, Assessment, Prioritization, & Referral
- All CoC & ESG permanent housing solutions are required to flow via CE
- All ESG Homeless Prevention services flow via CE

Homeless Management Information System (HMIS)

- CoC data requirements
- HUD required report (Project APB | SA, etc.) generation



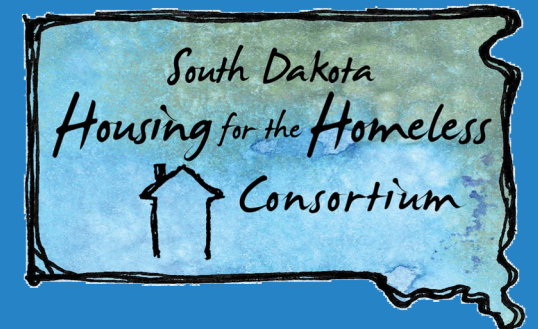
CoC Project Types

Permanent Supportive Housing (PSH)

- Disabled household member, typically adult head of household
- Lease & must be for a term of at least one year, renewable
- May be single site, scattered sites or clustered, & can integrate with affordable or market-rate units
- Services must be offered, may vary depending on the needs
- Dedicated & Dedicated PLUS PSH include additional requirements related to length of time homeless & where participants need to have resided

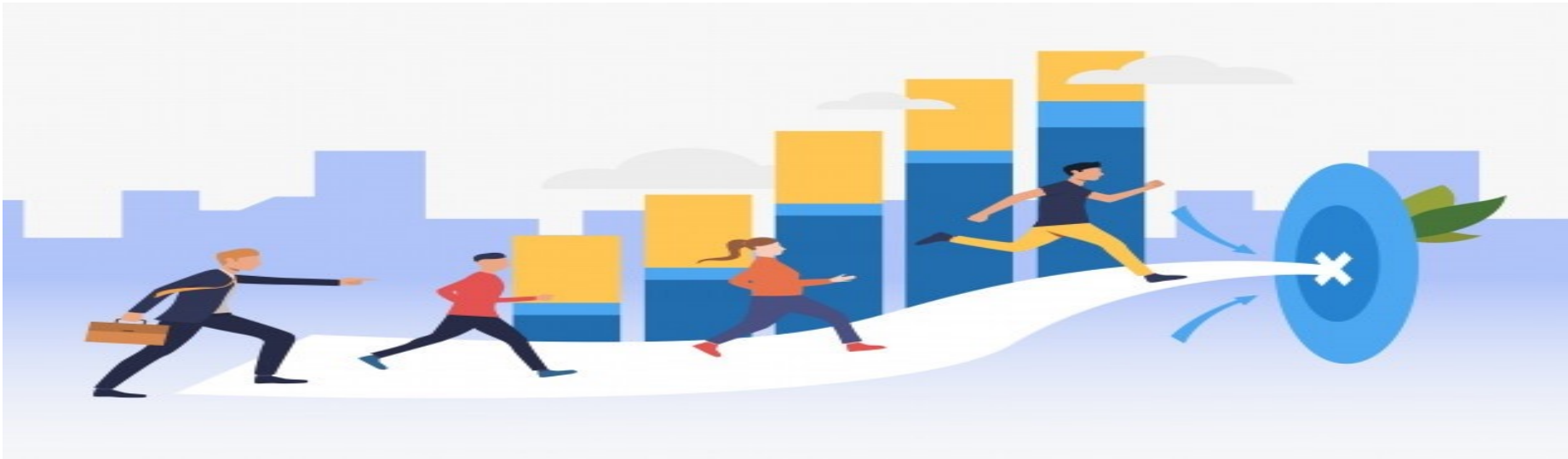
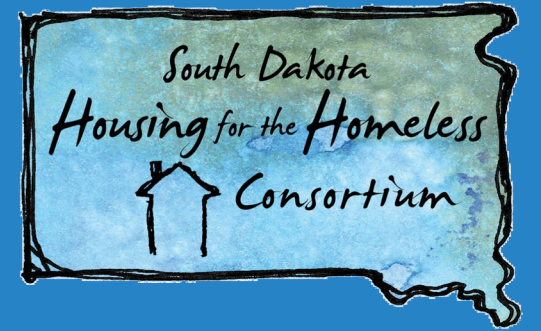
Rapid Re-housing (RRH)

- Funds may be used to provide supportive services & short- or medium-term tenant-based rental assistance.
- Projects may provide a maximum of 24 months of rental assistance.
- Lease required for all PH: RRH & must be for a term of at least one year

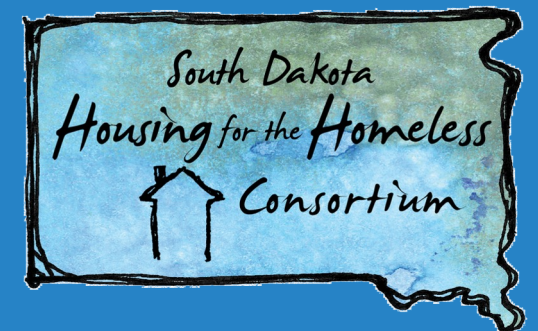

2021 CoC NOFO – Eligible Applicants

2022 CoC NOFO – May claim their geography & form COC, Tribes may join existing CoCs, Tribes may form new cooperative COCs, formula funding provided via HUD based on geography

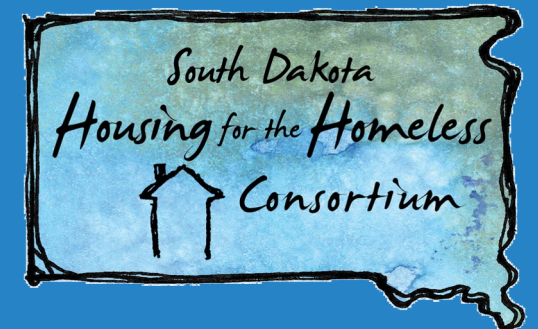


2022 CoC Competition

Tribes & CoC Funding

2022 HUD Notice – CoC Program Registration

- Tribes and TDHEs must register by 5 PM April 7, 2022 deadline to establish own CoC
- Tribes need provide Tribal Resolution to join SD-500 CoC by April 4, 2022



CoC 2022

What does this mean for Tribes and TDHEs?

- Tribes or TDHEs may be Collaborative Applicants
- Tribes or TDHEs may register as Collaborative Applicants & claim geographic areas in their formula areas



2022 CoC Competition

Tribes & CoC Funding

Tribal land geographies not claimed by either tribes or existing CoC via “Tribal Resolution” result in potential homelessness related funding being unable to be access for 2022 CoC Competition

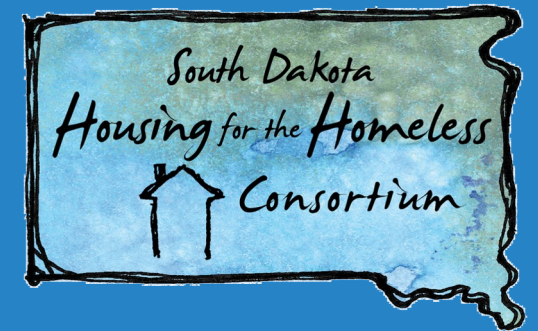

HOME American Rescue Plan (ARP)

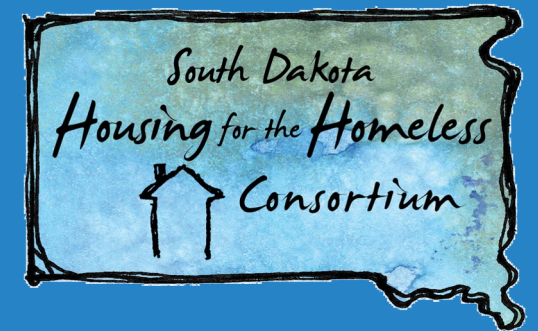
- South Dakota allocated approximately \$9.3 million
- Published CPD Notice 21-10
- No match requirement
- Must be used by September 2030
- Eligible activities include:
 - Affordable Rental Housing
 - Tenant-based Rental Assistance (TBRA)
 - Supportive Services
 - Non-congregate Shelter (NCS)



HOME ARP Qualifying Populations

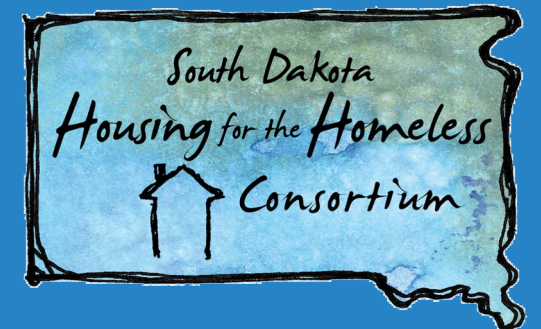
- Homeless – (McKinney Act definition at 24 CFR 91.5)
- At-risk of Homelessness (McKinney)
- Fleeing/Attempting to Flee Domestic Violence, Dating Violence, Sexual Assault, Stalking, or Human Trafficking
- Other populations where assistance would:
 - Prevent the family's homelessness; or
 - Serve those with the greatest housing instability

*Veterans and families including a veteran member that meet one of preceding criteria



HOME ARP Rental Housing

- Can be permanent or transitional
 - Acquisition of standard rental housing
 - Construction of rental housing
 - Rehabilitation of rental housing
 - Includes conversion of nonresidential buildings to housing
- Not less than 70% of total HOME ARP rental units assisted by SDHDA with HOME ARP funds must be restricted for occupancy by qualifying households – “QP units”
- Not more than 30% of total HOME ARP rental units assisted by SDHDA may be restricted by low-income households (80% AMI called “LI Units”)



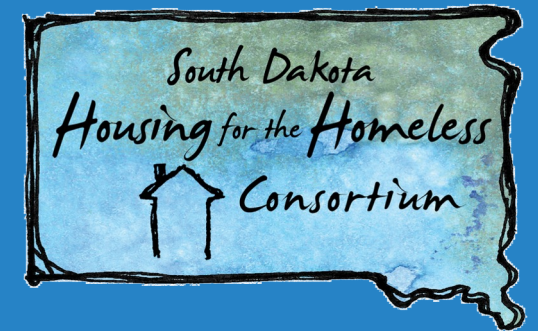
HOME ARP TBRA

- Can assist to pay rent, security deposits, utility payments, and utility deposits
 - A PJ may provide up to 100% of rent and utility costs
 - Assistance is tied to the qualifying household rather than the units
 - Household can take assistance to another unit that is rent reasonable and meets applicable property standards
- *Cannot be used in conjunction with homebuyer programs



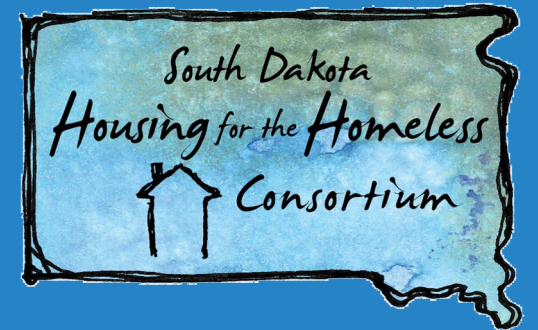
HOME ARP Supportive Services

- Eligible activities include:
 - McKinney-Vento Supportive Services – adapted from the services listed in Section 401(29) of the McKinney-Vento Homeless Assistance Act
 - HOME-ARP Homeless Prevention Services – adapted from eligible homelessness prevention services under Emergency Solutions Grant (ESG) regulations and are revised, supplemented, and streamlined
 - Housing Counseling – as defined in Part 5, including requirement that counseling only be provided by HUD-certified housing counselors
- Eligible Costs include: Child care, Education Services, Employment Assistance and Job Training, Food, Housing Search and counseling services, Legal services, Life Skills Training, Mental Health Services, Outpatient Health Services, Outreach Services, Substance abuse treatment services, Transportation, Case Management, Mediation, Credit Repair, Landlord/tenant liaison, Services for Special populations, Financial Assistance costs



HOME-ARP Non-Congregate Shelter (NCS)

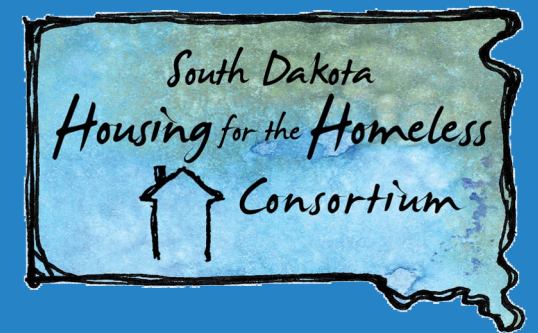
- For purposes of HOME-ARP, NCS is defined as one of more building that:
 - Provide private units or rooms for temporary shelter
 - Serve individuals and families that meet one or more of the qualifying populations
 - Do not require occupants to sign a lease or occupancy agreement
- Eligible Activities:
 - Acquisition of structures
 - New Construction, with or without land acquisition
 - Rehab of existing structures such as motels and nursing homes



HOME- ARP Wrap-up

- SDHDA staff will be holding public meetings this January in Rapid City, Pine Ridge, Sioux Falls, Yankton, Aberdeen, and virtually in Pierre
- Need to create the HOME-ARP Allocation Plan with input from stakeholders to identify gaps in the current system
- Lots of information on HUD Exchange such as webinars, fact sheets, PowerPoints (also contact SDHDA for more info)
- Once HOME-ARP Allocation Plan is finalized will need to be approved by HUD

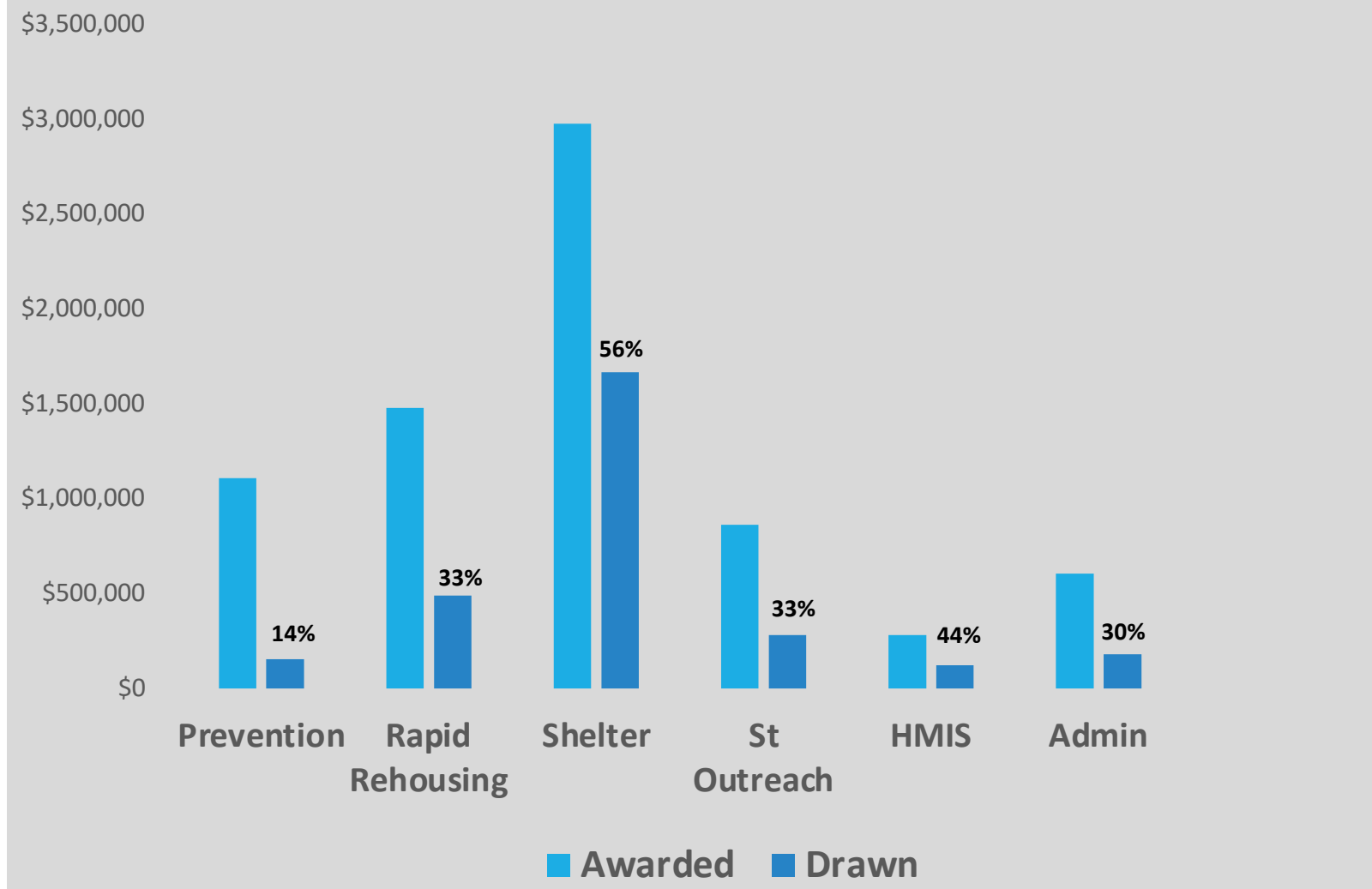

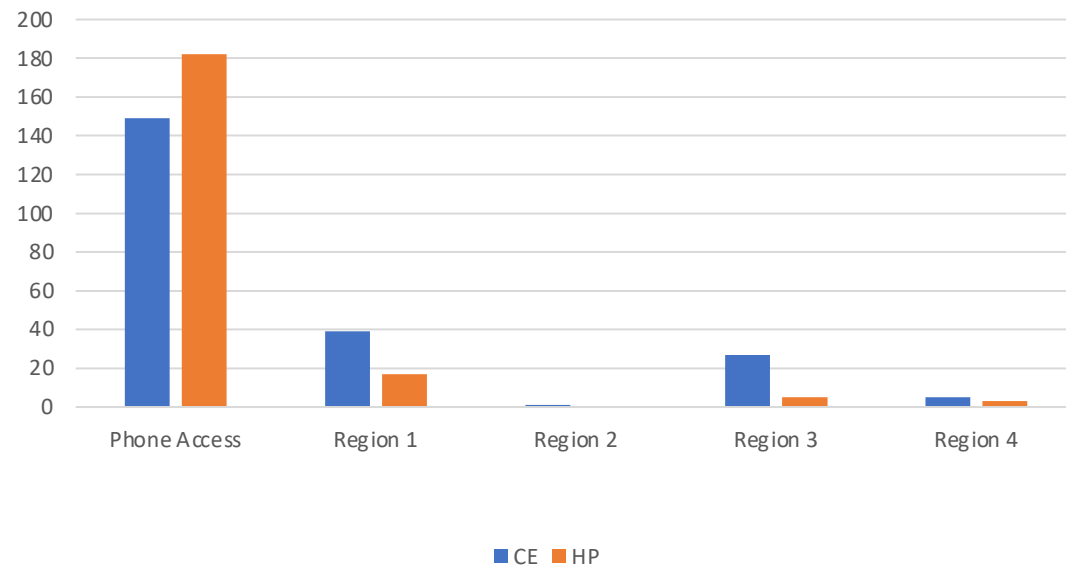

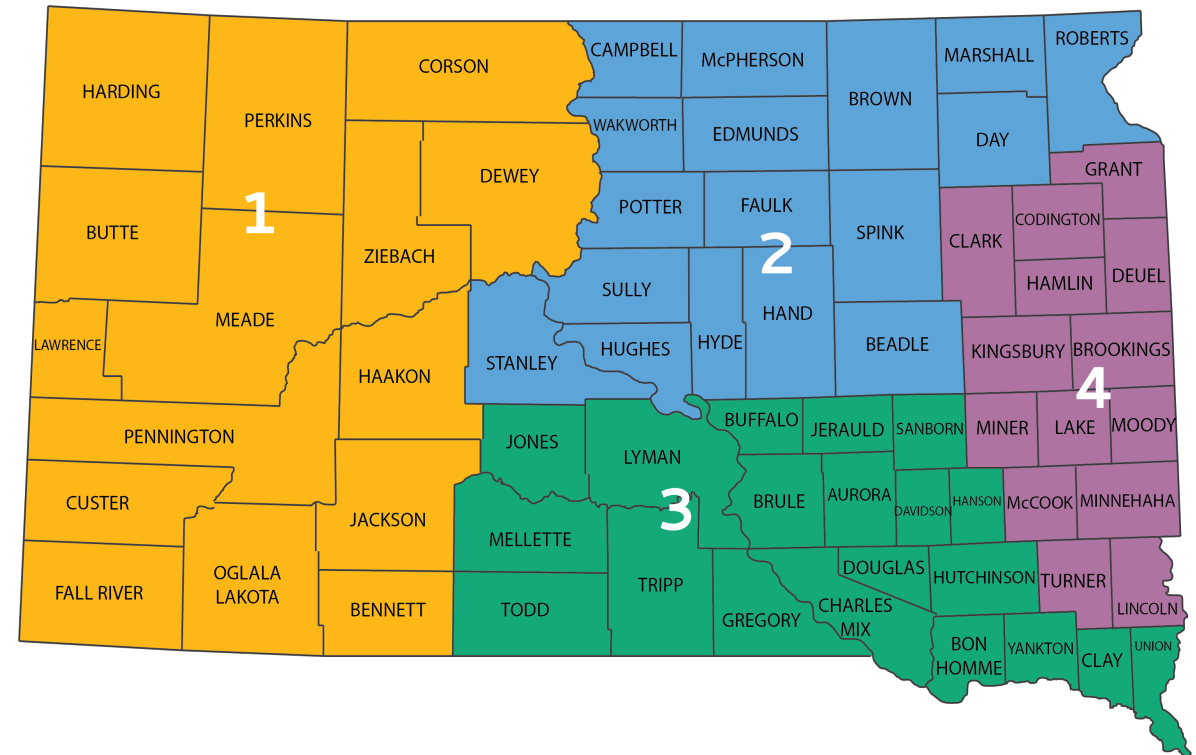

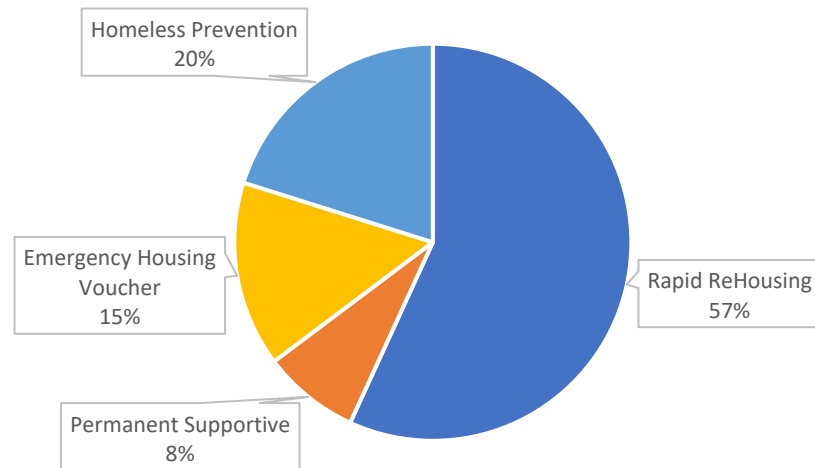

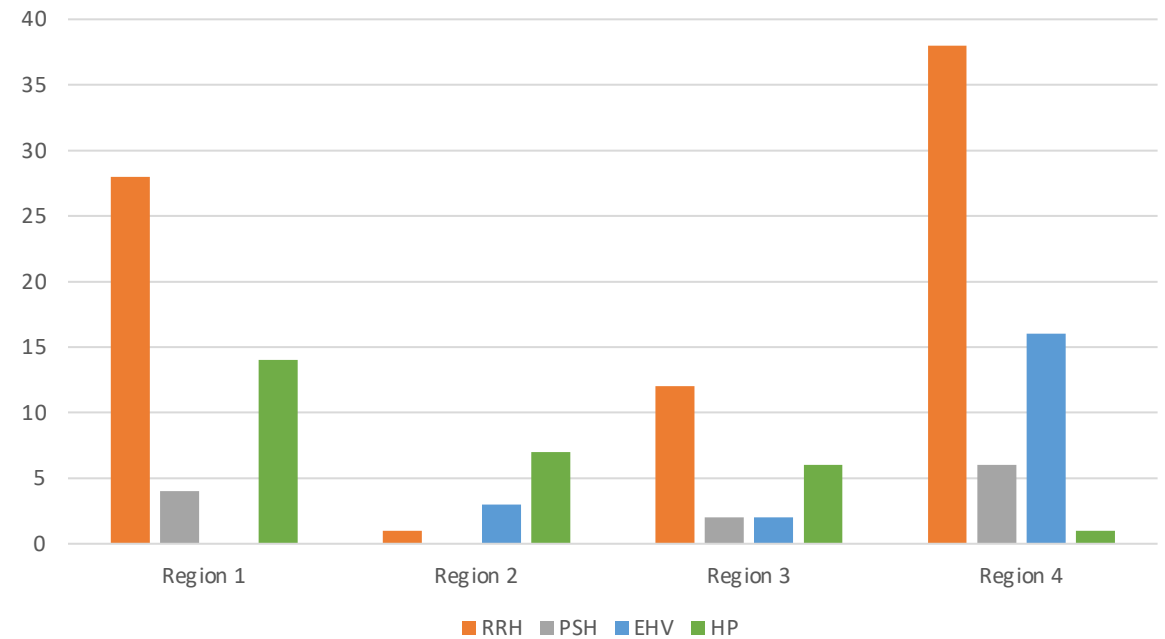

12.1.21-2.28.22

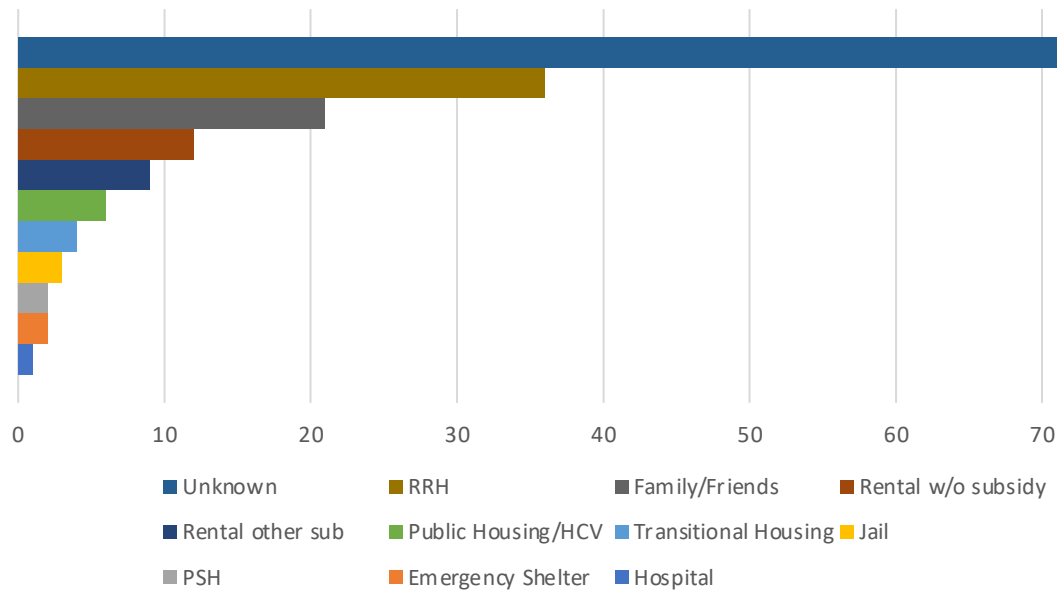

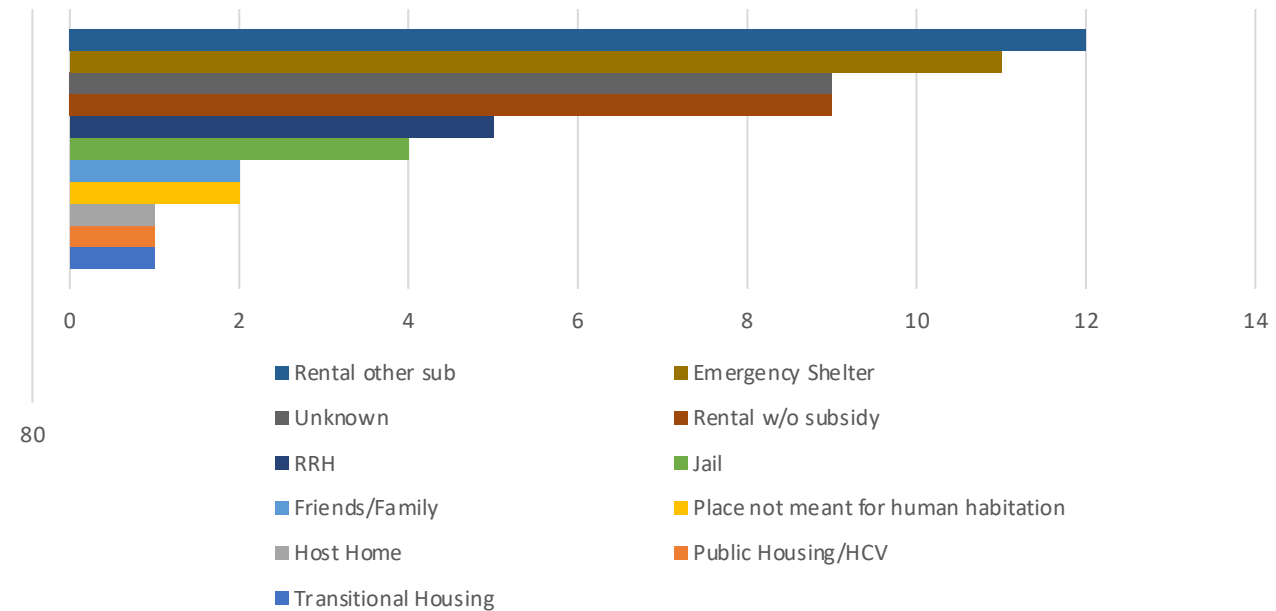
