The South Dakota Statewide Homeless Management Information System (SDHMIS) is administered by South Dakota Housing Development Authority (SD-500 CoC - Collaborative Applicant). SDHMIS is a computerized data collection application designed to capture client level information over time on the characteristics and service needs of homeless persons and families. The development of SDHMIS includes 1) Bringing the power of computer technology to the day to day operations to individual homeless assistance providers. 2) Bringing together providers within and across the statewide implementation in a coordinated and effective housing and service delivery system for the benefit of homeless clients and those at risk of homelessness. 3) Obtaining and reporting critical aggregate information about the characteristics and needs of at risk and homeless persons. 4) Providing a source of data for decision making processes. 5) A vital part of Coordinated Entry System processes and data collection and reporting.

There are currently 79 active users and 35,096 client records for the HMIS project. There were 26 new users trained in the project during the most recent Annual Performance Report time frame of July 1, 2021 to June 30, 2022. Agencies providing services via Runaway Homeless Youth (RHY), Support Services for Veteran Families (SSVF), Health Care for Homeless Veterans (HCHV), Grants Per Diem (GPD), Emergency Solutions Grant (ESG), Continuum of Care Funded (CoC), and VA HUDVASH are located in HMIS. Efforts at increasing HMIS coverage are continuing as part of Coordinated Entry System (CES) development, and as an important part of the HMIS NOFA activities. The HMIS NOFA grant was recently amended and a time extension was granted that should allow for further expansion of the HMIS and further improvements in the training of end users. The ESG-CV funding has resulted in a large increase in the percentage of Emergency Shelter (ES) Beds in HMIS. The increase coverage from CES implementation, ESG-CV grant funding, and HMIS NOFA integration is resulting in additional costs for continued development of software, additional fees associated for adding users, new and current end user training and monitoring, and for the additional data storage needs evident due to the expansion of the HMIS.

HMIS Administrator obtains stakeholder involvement via the HMIS Committee Meetings and by email contact with the HMIS agency users or Contributing Homelessness Organizations (CHOs). The CoC Administrator also follows up with CoC Grantees to obtain stakeholder involvement via the CoC Grantee Work Group meetings. The CES Administrator obtains stakeholder input via the CES Committee Meetings. In these ways the CoC seeks out and obtains HMIS stakeholder involvement from multiple sources and multiple individuals.
