### 3B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project.**

South Dakota-500 CoC is South Dakota Housing for the Homeless Consortium (SDHHC). SDHHC has implemented a Coordinated Entry System (CES) that covers the entire geography of the state, is easily accessible by individuals and families seeking housing or services, is well advertised, and includes a comprehensive and standardized assessment tool. The statewide CoC covers a vast geography and includes urban and rural areas as well as nine Tribal Indian Reservations. South Dakota has a population of 878,000 and covers 77,184 square miles.

SDHHC engaged in a CES design lab in August of 2017 which brought together stakeholders statewide. SDHHC, with the guidance of a contracted consulting firm, created action steps and pursued these action steps culminating in CES being implemented statewide. SDHHC CES is designed to coordinate outreach, intake, assessment, prioritization, and referral processes. CES implementation represents a significant shift in the practices of SDHHC and reflects best national practices and correlates with HUD funding requirements. The project funds will be utilized for costs associated with operating statewide CES including costs incurred; managing a by name list, Helpline Center statewide CES telephone access, HMIS costs for program developments, modifications, management for CES workflow and referral process, organizational management costs, and user fees and data storage of CES processes in HMIS. Additional associated costs include CES Access Point, Regional Coordinator, Receiving Agency, and other stakeholder training and education, as well as, CES management, monitoring, and evaluation activities.

CES is available to all eligible persons. People in different populations and subpopulations in the geographic area of the state have fair and equal access to CES regardless of the location or method they access the system. There are processes in place to communicate with individuals with disabilities and access is accessible for individuals with disabilities. Reasonable steps have been taken to ensure those with Limited English Proficiency (LEP) have access to CES. Advertising for CES has been completed by use of fliers and targeted letters to stakeholders including all agencies and groups identified as serving or coming into contact with persons at risk and experiencing homelessness. Agencies and programs providing an array of social services have been targeted with information explaining CES process and accessibility. Fliers have been placed in places that those seeking housing assistance with housing crisis have frequented. Information on CES Access Points locations and hours of operation are posted to SDHHC web page. Street Out reach staff across the state have been provided with information to assist those with the highest barriers to access assistance in CES.

Referral process in CES is completed via case conferencing on a regional level. The state has been organized into four regions and each region contains at least one physical Access Point and there is a statewide call in center Access Point via Helpline Center available from anywhere in the state via telephone access. Case conferencing brings together; Access Point Staff, Regional Coordinators, Receiving Agencies, CES Program Manager, and other community stakeholders to make decisions on housing offers based on prioritization model that prioritizes the highest need participants. Participants in CES are reviewed in case conferencing and prioritized for the appropriate housing services using uniform and coordinated prioritization and referral processes. Written CES policies and procedures contain uniform processes.
