PAC Membership Facts

- Elected by SDHHC membership
- Two Co-Chairs, Secretary/Treasurer
- Eleven PAC members total
- Terms are four years
- Members allowed consecutive terms
- PAC members may complete vacated or full term
- PAC Code of Conduct agreement required

PAC Duties

1. Governing Board of SDHHC
2. Approve documents, policies, & procedures
3. Complete monthly conference calls
4. Attend quarterly SDHHC meetings
5. Participate in other SDHHC committees
6. Oversee the Continuum of Care Competition

PAC CoC Competition Responsibilities

Based on HUD CoC NOFA;

- Develop timeline for CoC application process
- List priorities for funding
- Solicit new and renewal applications
- Create ranking tool for applications
- Rank applications and place applications in funding tiers
- Participate and review collaborative application

PAC Reimbursement Plan

PAC participation includes time & travel costs

- SDHDA, Planning Grant may mitigate costs
- Reimbursement options to be standardized
- Otherwise, non-reimbursed costs for travel
- Per diem organized & based on state levels
- Some PAC members are not currently reimbursed by employers
- Plan seeks to mitigate the costs incurred.
- Implement prior to June 2019 elections

SDHHC Initiative

Youth Advisory Board (YAB)

- Youth Committee - Melissa
 - Developing YAB - Report
 - HUD best practices aligned
 - Involves multiple agencies
 - Seeks to establish youth leadership culture
 - Prepares for YHDP application process

Point-In-Time Count Report

2019 PIT Count numbers are not available.

Goal is to have information prepared by end of March.

Initial analysis points to reduction over-all for Point-In-Time Count homelessness as compared to 2018.

Domestic Violence program numbers appear very similar to the 2018 count.

2019 PIT/HIC Debrief

What worked well?

- Command Center report generation
- Volunteer phone contact availability
- Partnering with Augustana University
- Data sorting allowed for reduction of duplication
- What else worked well?

2019 PIT/HIC Debrief

What did not work well?

- Mobile App surveys included a large number observation surveys
 - Placement of observation survey button in App
 - Large numbers of paper surveys received
 - Count organization difficulties in some areas



SDHDA has entered Phase 2 (\$150,000 funding limit)

- TA provider - Budget & Proposal - Narrative
- Phase 2 - Due March 28th
- September 2019 grant implementation
- Goals
 1. Data quality increase - HMIS training platform development,
 2. HMIS participation increase,
 3. Data transfer capabilities

Coordinated Entry System (CES) Implementation

- CES committee meets monthly
 - Includes 4 Regional Coordinators, 4 Access Points, Case Conferencing partners, SDHDA
 - Current work includes; establish CES training protocol, formalizing housing referral processes and case conferencing procedures in all regions, identifying gaps, reviewing CES HMIS info, expanding CES implementation, closing side doors
