Greetings South Dakota Housing for the Homeless Consortium (SDHHC),

The PAC is the governing board of SDHHC which is SD-500 Statewide Continuum of Care (CoC). SDHHC will conduct the yearly PAC election on June 16 during the quarterly meeting of the SDHHC. Since the homeless summit has been canceled for 2020, the PAC elections will be completed somewhat differently than in the past. The plan is to utilize an on-line survey tool during the SDHHC quarterly meeting to complete the election. There are two PAC terms expiring one each from Rapid City and Sioux Falls and are full four-year terms. PAC members are allowed to seek reelection.

The following is a list of PAC membership facts. 1) PAC is elected by the SDHHC membership. All SDHHC members are allowed a vote. All persons with an interest in preventing and resolving homelessness and persons with a lived experience may become a Consortium member. 2) There are 11 PAC members and this includes two Co-Chairs and a Secretary/Treasurer. 3) PAC terms of service are four years. A PAC member may be elected to serve out a vacated term and in this case the term is the remainder of the vacated term. 4) All PAC members must complete a PAC Code of Conduct Agreement.

PAC duties include various important tasks. 1) PAC is the governing board of SDHHC and approves all official documents, policies, and procedures for SDHHC. 2) PAC members attend monthly conference call meetings. A quorum of PAC members is required to conduct official PAC business. The current monthly conference call meeting is, 2<sup>nd</sup> Thursday of each month at 11 am, Central Time. 3) PAC members attend quarterly meetings of the full membership of SDHHC. 4) PAC members perform leadership activities for SDHHC and represent the organization in various ways, including membership in other SDHHC committees. 6) PAC oversees the annual Continuum of Care funding competition.

The PAC CoC funding competition responsibilities are an important duty of the office. Based upon the annual CoC Notice of Funding Availability (NOFA) the PAC is responsible for development and approval of the following. 1) Develop timeline for CoC application for process. 2) List priorities for CoC funding. 3) Solicit new and renewal funding applications. 4) Create ranking tool for applications. 5) Rank applications and place in funding tiers. 6) Participate in creation and review of CoC collaborative application.

PAC membership includes investment of time and travel costs. CoC Planning Grant funds are utilized to mitigate these monetary costs for PAC members by providing per-diem, mileage, and lodging reimbursement based upon South Dakota state travel rates.
