2021 CoC NOFA Solicitation of New Agencies & New Projects

The South Dakota Housing for the Homeless Consortium (SDHHC) is soliciting applications from new agencies and those currently receiving Continuum of Care funding interested in providing new innovative housing opportunities designed to successfully resolve homelessness experiences for individuals and families. Applicants interested in developing new projects providing Permanent Supportive Housing, Rapid Re-Housing, or Combined Transitional Housing – Rapid Rehousing should contact SDHHC and make plans to complete the pre-application for the 2021 Continuum of Care Competition. The pre-application process helps to determine the feasibility of new project proposals. The Consolidated Appropriations Act, 2021 allows Indian Tribes and Tribally Designated Housing Entities to be eligible entities or subrecipients of the CoC Program. Applicants that are new to CoC funding are encouraged and invited to consider and complete the application processes.

Funding will come from the US Department of Housing and Urban Development, Office of Community Planning and Development's Continuum of Care Program -<u>https://www.hudexchange.info/programs/coc/.</u> Funds may be used for new construction, rehabilitation, supportive services, operating and leasing, and rental assistance. The 2021 funding may include bonus funding targeted to providing housing and services to survivors of domestic violence, dating violence, and stalking, as well as, CoC bonus funding opportunity. Funding is allocated by competitive processes and may be obtained for new projects from either reallocation of existing projects or bonus opportunities. Potential applicants should review the Notice of Funding Opportunity (NOFO) for FY 2021 Continuum of Care Competition.
