

South Dakota Housing Development Authority is the (CES SSO Grantee and Lead, Collaborative Applicant, and HMIS Lead). SD-500 is a statewide CoC and locally known as South Dakota Housing for the Homeless Consortium (SDHHC). The SDHHC operates a statewide Coordinated Entry System comprised of eight (8) publicly advertised access points, a toll-free phone assessment line and nine (9) additional stakeholder partners with trained housing assessors. This allows for full geographic coverage access for the entire CoC. Households experiencing homeless or at risk of homelessness are assessed utilizing a standardized process and assessment tool, gathering necessary information including but not limited to current living situation, household demographics, history of housing and homelessness, barriers and unmet service needs.

SDHHC does not utilize CES to manage emergency shelter capacity; thus, households do not need to access CES for emergency shelter or crisis needs. CES is responsive to the specific needs of household's exposed to or experiencing domestic violence, sexual assault, stalking and human trafficking and has provisions in place for households to connect with victim service providers directly for housing supports at every access point and in coordination of services following assessment.

Once assessed; households are prioritized and referred in accordance with CoC adopted prioritization standards; utilizing a biweekly case conference process facilitated by region and managed by the CES Administrator.

The CES system is managed within the HMIS system from access through housing referral. CES SSO grant funds will be utilized for costs associated with operating CES including staff time, operation of the 1-800 number access point with two full time housing assessors, stakeholder partner training, program evaluation and HMIS expenses. Staff time includes 2 full time housing assessors and CES Administrator time dedicated to, managing a by-name list, organizing and leading regional case conferencing meetings for the 4 CES regions, oversite of the daily operation of CES, data evaluation, strategic planning and implementation and monitoring all functions in the system. Training and support for assessors, access points and stakeholder agencies, includes the application of trauma informed, low barrier interventions, motivational interviewing and culturally responsive engagement. Access Points, Regional Leadership, Case Conference Teams, Referral Agencies, CoC, ESG, and HMIS leadership are included in CES Committee membership, evaluation and annual in person training.

CES is available to all persons and all geographic areas of the state regardless of their location or method of access. Advertising by CES has been completed by use of dedicated webpage, fliers/posters for the general public posting, distribution of thousands of business card sized info and poster sized flyers and targeting email and postal mailing of CES materials and pamphlets. SDHHC partners across the statewide CoC post posters in public areas such as libraries, courthouses, city offices, state offices, hospitals, and public housing authorities.

The Referral process in CES is completed via case conferencing on a regional level via the HMIS system. CES is organized into 4 regions and each region contains at least one publicly advertised physical access point in addition to the 1-800 assessment line. Assessors at access points complete assessments of individuals in HMIS. At time of assessment, individuals who may be best served by mainstream resources outside of the CES process may be diverted in order to quickly connect households to resolution. Individuals may voluntarily divert out of CES if they are a veteran or victim of domestic violence and would like to seek assistance directly from a veteran or domestic violence service provider. All households are screened for recent DV experience in all its forms. All access points are trained in the sensitive nature circumstances of domestic violence/trafficking survivors and arrange for direct connection to victim service provider support networks. During the intake process individuals are assessed with one of 3 VI-SPDAT tools (for singles, families or young adults) and other data points are collected that assist with determining eligibility criteria and needs of participants including chronic homelessness status and associated barriers to housing. CE enrollments are placed in the appropriate queue congruent with their current living situation. Queues are managed by region, household type, or chronic homeless status to manage the case conferencing process, housing match and ensuring accurate referrals households are eligible for. The referral process targets non-chronic and lower acuity households for rapid re-housing, targets youth and DV survivors with transitional housing and chronically homeless with the highest acuity scores for permanent supportive housing. While households may have recommended matches for a particular housing type; households are referred for all housing options which they are eligible for. Case conferencing includes Access Point staff, Regional Leaders. Referral Receiving Agencies, agencies providing services, CoC, ESG, and HMIS staff, and other stakeholders to effectively make decisions on housing offers based on prioritization model that prioritizes the highest need participants based on their individual assessments. Once housing is identified the CES Administrator or another CES Lead agency staff designee generates a referral email via HMIS to the service provider. The service provider will either accept or reject the referral and indicate the reason for the decision. Until individuals are housed, they will continue to be listed on the queue and reviewed in case conferencing. SDHHC has adopted written CES policies and procedures that correspond with HMIS governance to allow for uniform assessment and referral process to occur. SDHHC has adopted as policy that Permanent Supportive Housing is targeted to persons who are chronically homeless and have higher VI-SPDAT score. SDHHC adopted as policy HUD Notice CPD-16-11, Notice on Prioritizing Persons Experiencing Chronic Homelessness and Other Vulnerable Homeless Persons in Permanent Supportive Housing. The Referral processes and results of referrals are regularly reviewed. Issues and concerns involving referral process are regularly addressed with individuals and agencies, in monthly CES committee meeting, and during annual CES training activities in order to ensure that CES enrolled households are directed to the appropriate housing and services available.
