# 3B. Project Description

# 1. Provide a description that addresses the entire scope of the proposed project.

The project targets individuals who were chronically homeless with disability of chronic substance abuse. Five individuals are able to receive rental assistance to enable them to reside in a building that provides permanent housing for this targeted population. This building, called Safe Home, is owned by the Minnehaha County Housing & Redevelopment Commission with operational and supportive services provided by Minnehaha County Human Services. The participants are able to maintain their housing through supportive services which include intensive case management, life skills training, payee services, daily meals and transportation services. Participants are, also, linked with appropriate community services including health care, addictions treatment and access to mainstream benefits and/or employment. By providing permanent housing with appropriate services in a harm reduction environment, the participants are empowered to make lifestyle changes that will improve their quality of life and break the cycle of homelessness.

This program has had success in utilizing available beds and keeping this extremely difficult population stably housed. 1) In the most recent APR reporting period, all available beds were nearly 100% consistently utilized. The program experienced some tenant turnover, but all beds were almost immediately filled with new program participants, providing stable housing to some of Sioux Falls' most vulnerable population. It is projected that this success will continue with at least 80% of the participants remaining stably housed at the end of the program year and/or exit to permanent housing. 2) Annual bed utilization will continue to be at least 90% or higher 3) Generally, there will be at least 20% turnover each year in program participation, or 1 in 5 participants. When new participants enter Safe Home, they generally have zero income and very few resources. Safe Home caseworkers work to apply for and obtain benefits for these new program participants. Thus, at least 20% of participants will begin receiving cash or non-cash benefits since many have a difficult time getting the necessary documentation to qualify for benefits on their own in addition to the benefits Safe Home already provides through food and other wraparound services.



- Utilities. Grant funds can be used to pay for costs of establishing utility assistance in the safe unit the survivor is transferring to.

- Housing Fees. Grant funds can be used to pay fees associated with getting survivors into a safe unit via emergency transfer(s), including but not limited to application fees, broker fees, holding fees, trash fees, pet fees where the person believes they need their pet to be safe, etc.

- Case Management. Grant funds can be used to pay staff time necessary to assess, coordinate, and implement emergency transfer(s).

- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).

- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.

B. VAWA Confidentiality Requirements.Examples of eligible costs for ensuring compliance with VAWA confidentiality requirements include:

- Monitoring and evaluating compliance.

- Developing and implementing strategies for corrective actions and remedies to ensure compliance.

- Training on compliance with VAWA confidentiality requirements.

- Reporting to CoC Collaborative Applicant, HUD, and other interested parties on compliance with VAWA confidentiality requirements.

- Costs for establishing methodology to protect survivor information.

- Staff time associated with maintaining adherence to VAWA confidentiality requirements.
